Nota: De acordo com o Decreto-Lei n.º 69/2023, de 21 de agosto, que estabelece o regime jurídico da qualidade da água destinada ao consumo humano, transpondo diversas diretivas, procedeu-se à alteração dos Valores Paramétricos (VP) dos seguintes parâmetros: Antimónio, Selénio, Boro, Cloritos e Cloratos

Informação complementar relativa à averiguação das situações de incumprimento dos VP (causas e medidas correctivas):

Causa do incumprimento **Cloro residual “no local”**: T1 - Dosagem inadequada de reagente

Embora se tenha verificado que o Parâmetro Cloro Residual “no local”, apresenta um valor acima dos valores recomendados (entre 0,2mg/l e 0,6 mg/l), mas, uma vez que os parâmetros Bactérias Coliformes e Escherichia coli apresentam valores de acordo com o Valor Paramétrico, considera-se o incumprimento fechado. No entanto foi corrigida a dosagem de reagente no tratamento.
